

FOR USE WITH ALL PHILCO SOCKET POWER UNITS



This dry, permanent, all metal Kuprox Rectifying Unit has been designed especially for use with Philos Socket Power Units. In addition to using an increased number of rectifying discs, because of the higher output voltage developed by the Philos transformer, half-wave rectification (the same as developed by the standard Philos electrlytic far) is utilized, thereby greatly simplifying installation. Only two simple connections are necessary, involving no changes whatever in wiring and requiring no tools to effect. This ex-

treme simplicity of installation and improved design eliminates all chances

of error and insures 100% satisfactory operation.

To install, simply remove the Philco electrolytic jar, set the Kuprox Unit in its place and connect the two leads formerly running to the old jar, to the corresponding terminals on the Kuprox Unit. These terminals are of the same special construction as used on the Philco jar, i.e., one a Fahnestock clip, the other a plain, pin prong, making wrong connections

impossible.

When once installed no water or other attention of any kind is required. Due to the higher maximum charging rate obtainable, the capacity of Kuprox equipped Philo Socket Powers is greatly increased, enabling them to operate much larger receiving sets than formerly. For a given charging rate current consumed is much less than with the old Philo jar, this effecting a substantial saving in cost of electric current consumed. Under normal conditions the Kuprox Rectifying Unit will last indefinitely without requiring replacement or adjustment of any sort.

Comparative charging rates on the various transformer taps provided for both the old Philco wet jar and Kuprox dry metallic replacement unit
