

Hi fellas! As individuals, it may sometimes seem that our personal opinions don't count. This is not so.

It's true that a lot of individual opinions that are the same can be a greater force than a single one, but *each one counts!* For instance, you may feel that income taxes are too high and that there's nothing you can do about it. Actually, if you were to write your Congressman to express your opinion, it could make a difference... because enough individual opinions like that would be a *powerful influence*.

Sometimes a thought expressed by *one person* can be such a good idea that it is all that is necessary to start action. This is another reason why an individual opinion counts.

There are examples of opinions in letters written to Philco having an effect on how things are done. One such example recently resulted in a change being made in *Philco Appliance Supervisor* magazine. A number of letters were received that suggested it would be helpful if the "other side" of a page on "Refrigeration" contained the same subject—rather than the beginning of another subject. Evidently, a number of service technicians file these articles by product category, and this was not possible when two products were on the same sheet of paper.

As a result, the matter was discussed at a meeting and a plan was designed to correct the problem.

Another example was "fold-out" schematics. There are usually advantages and disadvantages to every system, and because of certain advantages, a number of schematics were produced in the "fold-out" style. Once again, your letters said this form was not as easy to use and that you preferred the regular "page" style. As a result, another change was made due to your comments.

It is not possible, of course, to follow every suggestion received. Many times there are reasons not known to an individual why certain things cannot be done, but this fact should not deter anyone from expressing an opinion. This situation sometimes applies to the Monthly Award letters. There might be a case of a servicing idea that has merit . . . however, if there is a standard recommended procedure already in existence, the idea cannot be given an award. Other examples of this may involve one specific brand name servicing tool, for instance—and one specific brand cannot be featured without casting a reflection on other brands. So, you can see there are many factors that must be considered.

Business, government, or any organization will almost always consider suggestions or criticism. And opinions can be expressed on things you favor ... it's like casting a vote. So, when you have a definite opinion about anything that affects you, remember to write about it—it makes a difference.





Did you ever have a customer complain about a service bill? Most service technicians have, but there's a way to eliminate most of the complaints.

The secret is to ITEMIZE the bill —the parts, labor, tax, and the description of the work you've done. Most customers won't complain if they understand *what they're paying* for.

To go to the opposite extreme, the customer gets a real shock if you hand her a bill like the one illustrated here:



A shock-producer.

Who wouldn't? The bill doesn't indicate any of the work that's been done. And, when the husband comes home that night, how will she be able to explain to him what you've done to justify that bill?

To keep satisfied customers, it is much better to take a little extra time to *itemize your charges* on the bill. Did you ever take your car to an automobile service agency for a repair job? Maybe you were handed a bill of \$72, but chances are that you had no argument because the total was itemized in amounts of a few dollars each and you couldn't find fault with any one of them.

The charges on the bills that you write for customers should be covered in five basic "categories":

1.	Description	4. Tax
2.	Parts	(if applicable)

3. Labor 5. Total

Description. This is where you can list every part of the job you did, including any checking or extra services you performed.

Parts. List each part used, with a separate price for each one. Describe the part so that the customer will know what it is. For instance, instead of writing "1-6BQ7," describe it more fully as "1-6BQ7 tube."

Labor. Charges for labor may be listed in one or more ways...you may charge a specific fee for the serv-

ice call, or you may charge on a time basis. A "pick up and delivery" fee may be listed as a separate item on jobs taken into the shop. The more that labor charges can be itemized, however, the more justifiable they will seem.

Tax. State or local taxes will be a separate listing in areas where they apply.

Total. With the itemization you have made, the total no longer will appear to be an arbitrary amount to the customer, and collecting will be an easier job.

Let's take a look at how a bill might appear when these principles are put into practice. The illustration (below) is for a solenoid and belt replacement on a washer, but notice the *itemization*.

One more "follow through" detail is to explain the bill to the customer when presenting it, and add a comment of "you may want to check my addition to be sure it's correct, Mrs. Doe." This comment (suggested in "Customer Psychology," Aug., 1957, *PST*) will "get the customer into the act" and into a position of "okaying" the charges.

Use a printed billhead, with your name on it, to make an impression of business reliability, and *take time to itemize*.






